

## 3/27/2009 Moran's Ninth "Partners in Conservation" Tour to be Held in Two Weeks in Central Kansas

### Moran's Ninth "Partners in Conservation" Tour to be Held in Central Kansas

HUTCHINSON - Congressman Jerry Moran has announced his upcoming conservation tour to learn more about conservation efforts in central Kansas. This year's ninth First District "Partners in Conservation" tour will feature stops in Reno, Marion, McPherson and Saline counties on Tuesday and Wednesday, April 7 and 8. Members of the media and press are invited to attend the tour.

"Conservation efforts and the protection of our natural resources are issues that every Kansan should care about," Moran said. "The conservation tour is a good opportunity for me to learn how private landowners, conservation groups and government programs are partnering to protect Kansas' environment. Information I learn on the tour is useful for me when making decisions in Washington, D.C."

Since coming to Congress, Moran has held regular conservation tours to study conservation practices in various parts of the state. This year's ninth tour will focus on a variety of conservation issues important to Kansas including water and soil conservation practices, wildlife habitat protection, grazing lands management, the Conservation Reserve Program (CRP) and preservation of wetlands.

On Tuesday, April 7, tour stops will feature presentations from the Natural Resources Conservation Service (NRCS), the Farm Service Agency (FSA), the U.S. Army Corps of Engineers and private landowners. Stops will include a CRP controlled burn demonstration site, a ranch in Marion County, Marion Reservoir, farms in McPherson County and the McPherson Valley Uplands. Topics of discussion will cover federal conservation programs, watershed and water quality issues, wildlife habitat protection, conservation tillage practices and irrigation systems.

The Wednesday, April 8, tour stops in McPherson and Saline Counties include presentations from NRCS, Kansas Alliance for Wetlands and Streams (KAWS), the Kansas Water Office, a local farmer and the City of Salina. Topics will include stream bank stabilization, sedimentation, no-till farming practices and residential water conservation programs.
