Celebrating Independence Day, Dedicating the Gray County Veterans Memorial

On Independence Day, I was in Cimarron to help area residents dedicate the community veterans memorial. More than 800 people attended the event outside the Gray County Courthouse, including about 100 Patriot Guard Riders from across the country. The memorial features nearly 2,000 names of veterans serving from Gray County, dating back to the Civil War. Plans for the memorial were in the works for nearly two years. It took the time and commitment of numerous

volunteers and leaders, including co-chairmen Wiley McFarland and Curtis Campbell and program speaker, Steve Irsik Jr. Their work is to be commended.

It was a wonderful event and fitting to come together on July 4th to dedicate this memorial, pay tribute to our military men and women, and honor generations of Gray County veterans who have answered our country's call to serve. For full text of my speech, [click here](#).

House Passes Cost-of-Living Adjustment for Veterans and Dependents

The House recently passed legislation I sponsored to provide an annual cost-of-living adjustment (COLA) for service-disabled veterans and their families. Beginning December 1, 2006, the Veterans' Compensation Cost-of-Living Adjustment Act would provide a cost-of-living adjustment to the compensation rates for 2.6 million veterans with service-connected disabilities and to the compensation rates paid to more than 340,000 spouses and children of service-disabled veterans. The cost-of-living adjustment is factored into various veterans' benefits programs.

Congress has approved such adjustments for veterans every year since 1976. This is one of the most important things our nation does for disabled veterans and surviving family members. Congress has a responsibility to care for veterans who rely on this benefit.

Attending the U.S. Senior Open in Hutchinson

On Wednesday, I had the opportunity to attend the U.S. Senior Open, which was held in Hutchinson at Prairie Dunes Country Club. This event brought 115,000 people to the area throughout Championship week. The tournament's spectators and players not only enjoyed good Kansas weather, but the golf course itself exceeded many peoples' expectations. Hutchinson is a great example of a progressive Kansas community that is always eager to extend its hospitality and share its attractions with visitors. I am proud of the community's accomplishment and pleased to have Kansas positively highlighted on a national level.

A tremendous amount of effort was needed to bring to realization this successful event. Specific thanks go to Allen Fee, General Chairman, Greg Conrad, Championship Director, and the several thousand volunteers whose hard work and determination helped bring an expected \$20 million economic impact to Hutchinson and other south central Kansas communities.

United Health Ministries Celebrates 20th Anniversary this Year

This week, I visited the Health Ministry Fund in Hutchinson to learn more about the programs, grants and services they offer. This organization, formed by the United Methodist Church with a portion of the proceeds from the sale of Wesley Hospital in Wichita, is celebrating its 20th anniversary this year. The Health Ministry Fund works to fulfill its mission of Healthy Kansans through philanthropy guided by Christian principles. The Health Fund serves the State of Kansas with special emphasis on the western two-thirds of the state. It was encouraging to see that from its beginnings with a \$30 million endowment, the Health Fund has made available grants totaling more than \$34.5 million to improve the health, healing and wholeness of Kansans. I appreciated meeting with Health Fund trustees Sheila Frahm and Janet Hamilton Newton, as well as Matt Kuzma, Kim Moore, Jeff Gamber, Virginia Elliott and Rachel Pearson.

Spending Time in Nickerson and Visiting with the Spearville Lions Club

This week, I spent time in the communities of Nickerson and Spearville. In Nickerson, I had the opportunity to meet with several area residents at various places in town, including the local post office, City Hall, Sunshine Cafe, Peoples Bank and Trust, Berridge's Grocery, Farmers Co-op and the Kwik Shop.

On Friday evening, I joined the Spearville Lions Club for a special meeting at St. John's Parish Center. I enjoyed visiting with the group about current topics, including immigration and farm issues. Spearville is home to a new wind farm that will generate 100.5 megawatts of energy, which is enough to supply approximately 33,000 homes. This will be a great addition to the economy of this Ford County community. I enjoyed meeting with the local Lions Club members at the invitation of Ken Domer and appreciated the hospitality of the club members and president Mike Shafer.

Attending Barton County Fair and Riding in McCracken Parade

On Saturday, I joined residents in Rush and Barton Counties for annual community events. In McCracken, the small community of about 200 people welcomed me for the local downtown parade. The day's events also included an alumni luncheon that drew many generations of McCracken natives back home. McCracken also hosted the 20th anniversary of its award-winning rodeo this weekend and honored the rodeo's founder, Jack Wilson, who passed away earlier this year. Mr. Wilson dedicated his life to the McCracken rodeo and transformed it into a notable annual Kansas event.

I later attended the Barton County Fair, just outside of Great Bend, for the annual watermelon feed. I enjoyed the opportunity to visit with many area residents attending the activities at the fair.
